<u>New Kids On The Block #GetOnTheBoat Video Sweepstakes 2017 Official Rules:</u> <u>Terms & Conditions ("Official Rules")</u>

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS "SWEEPSTAKES." BY ENTERING THIS "SWEEPSTAKES," YOU AGREE TO BE BOUND BY THESE "OFFICIAL RULES" OF WHICH YOU HAVE FULL UNDERSTANDING AND WHICH CONSTITUTE A BINDING AGREEMENT BETWEEN YOU ON THE ONE HAND, AND "SPONSOR" ON THE OTHER.

1. <u>Sweepstakes Description</u>. The New Kids On The Block #GetOnTheBoat Video Sweepstakes ("Sweepstakes"), sponsored by the NKOTB II, Inc. 2. <u>Eligibility</u>. Sweepstakes are offered only in the 50 United States and the District of Columbia to legal United States residents at least twenty-one (21) years of age at the start of the Promotional Period. Void where prohibited. Employees, and their immediate families (spouses, parents, children, siblings, and their respective spouses), including household members of employees of Sponsor are not eligible to enter. ENTRANTS ALSO WAIVE ANY RIGHT TO INSPECT OR APPROVE ANY SUCH USE OF THEIR VIDEO OR OTHER RIGHTS GRANTED, AND/OR MORAL RIGHTS, OR RIGHTS TO ATTRIBUTION.
